

UNIVERSAL SCENE DESCRIPTION ASSET DEMONSTRATION LICENSE AGREEMENT

This license is a legal agreement between you and NVIDIA Corporation ("NVIDIA") and governs your use of the NVIDIA Universal Scene Description (USD) assets provided hereunder ("ASSETS").

This license can be accepted only by an adult of legal age of majority in the country in which the ASSETS are used. By entering this license, you agree to bring any claims in your individual capacity, and you waive the right to a trial by jury or to participate in a class action or other type of representative proceeding. If for any reason this license to arbitrate is found not to apply to a dispute and as a result a dispute proceeds in court rather than in arbitration, any dispute shall be resolved in the state or federal courts located in Santa Clara County, California. Nothing in this license shall prevent a party from seeking injunctive or equitable relief from the courts in any jurisdiction to protect data security, intellectual property rights, or other proprietary rights.

NO ASSIGNMENT. This license and your rights and obligations thereunder may not be assigned by you by any means or operation of law without NVIDIA’s permission. Any attempted assignment not approved by NVIDIA in writing shall be void and of no effect.
